With reference to your letter dated 5<sup>th</sup> July'2006, formal recognition is hereby granted to St.Thomas Residential School, Naharlagun, District, Papum Pare, Arunachal Pradesh run and managed by Loyola Charitable Trust-India, Naharlagun for running classes I to VIII standard with effect from 23<sup>rd</sup> May'2006, the date of approval from the competent authority.

The recognition is granted on the following terms and conditions:-

1. The guidelines in respect of recognition of school conveyed through order No.EDA.20/90-91 (Vol-II), dated 22<sup>nd</sup> January'2004 shall have to be observed in letter and spirit. Further, the recognition of the school does not carry any financial commitment from the Govt. side.

In addition, the following additional guidelines shall be strictly complied with:-

1. Arunachal Pradesh traditional culture must be preserved.
2. Syllabus prescribed by the Directorate of School Education AP/CBSE, New Delhi, for the school will have to be followed.
3. No religious activity should be under taken either directly or indirectly in the school / hostel campus.
4. There should be emphasis on the quality education.
5. Norms of recognition applicable in respect of other institution shall also be applicable to the institution.
6. Direct or indirect violation noticed in respect of the above mentioned conditions might lead to deterrent action including closure of the school.
